



## AETOS VPS Sponsorship Plan

### 1. VPS Service Plan

\* Please be noted that trading volume are subject to following conditions:

- 1) Trading products are limited to Forex and Spot Metals only;
- 2) Trading volume calculation will be limited to closed trades only.
- 3) If the required minimum monthly trading volume is not reached for the chosen plan tier by end of month, fees will be charged on the difference between the chosen plan cost and the eligible sponsored tier cost (if monthly volume <10 lots, then fees will be charged in full).

### 2. VPS Service Payment And Reimbursement Procedures

#### 2.1 Payment

Clients have to pay upfront once they successfully register for the VPS service. The fee is allowed to get reimbursed from AETOS afterwards if the applicant reach the required monthly trading volume. VPS service monthly fee will be debited from the applicant's trading account by AETOS on the first day of the service month according to the chosen service plan;



New subscribers will only be charged for the number of days covered in the month since joining. The fee will be debited on the same day when AETOS sends the VPS service approval email to the applicant.

## 2.2 Reimbursement

### 2.2.1 Trading volume calculation

AETOS will carry out monthly trading volume review after market closes on the last trading day of each calendar month. It's not acceptable to aggregate trading volume across accounts under the same account holder.

For new subscribers, the trading volume requirement for the first month will be calculated on a pro-rata basis (results round up to the nearest integer number), using the number of days covered in the month since joining, over the total number of days in the month.

### 2.2.2 Fee refund

- 1) If the trading volume requirement for the chosen plan has been reached, the monthly VPS service fee will be fully refunded to applicant's trading account by the following month end;
- 2) If the trading volume requirement for the chosen plan has not been reached, AETOS will review if the trading volume has met any lower level requirement and the difference between the chosen tier plan cost and the eligible sponsored tier cost will not be refunded;
- 3) If the monthly trading volume is less than 10 lots, VPS monthly service will be charged in full and therefore the applicant account will not be subject to any refunds.

#### Example:

Applicant joined the AETOS VPS Sponsorship Plan (**Standard Plan**) on 20 June 2021.

#### Service Fee Payment

According to the chosen plan, AETOS debited **USD 20** on 20 June 2021 from applicant's trading account for the VPS service of the month:

$$USD 20 = \frac{10 \text{ days}}{30 \text{ days}} \times USD 60;$$

After the market closed on 30 June 2021, AETOS performed a trading volume review. As the applicant joined the plan on 20 June 2021, the trading volume requirement for the first month was calculated on a pro-rate basis:

$$7 \text{ standard lots} = \frac{10 \text{ days}}{30 \text{ days}} \times 20 \text{ standard lots.}$$



- In situation that the required trading volume had been reached, the fee could be refunded by the end of July 2021;
- In situation that the required trading volume had not been reached, AETOS would review if any lower-level plans' requirement had been reached (**Basic** or **Basic Plus**), and the difference between the chosen tier plan cost and eligible sponsored tier cost was non-refundable;
- If the total trading volume of June was less than 3 standard lots, the service fee was hence charged in full and the applicant was not entitled for any refunds.

### 3. Unsubscribe Service

Users may unsubscribe VPS service by sending email to [cs\\_markets@aetoscg.com](mailto:cs_markets@aetoscg.com). The VPS service will be terminated on the same day when AETOS replies on your unsubscribe email.

You will be only charged for the days covered in the last service month. The service cost and trading volume requirements under the AETOS VPS Sponsorship Plan will be calculated on the pro-rata basis (results round up to the nearest integer number), using the number of days covered in the last service month, over the total number of days in the month.
